## Glossary of the Terms used in the Fee Information Document

<b>Service</b>	<b>Definition</b>
<b>Credit in a payment account</b>	A service referred to in Article 2 item 16b of the Act of 19 August 2011 on payment services.
<b>Credit transfer</b>	A service referred to in art. 3 par. 4 Act of 19 August 2011 on payment services, excluding the internal credit transfer, SEPA credit transfer and credit transfer in a foreign currency.
<b>SEPA credit transfer</b>	A service initiated by the payer consisting in enabling the transfer of funds in Euro, from the payer's payment account to the payee's payment account, if both or one of the service providers are active in the Single Euro Payments Area (SEPA).
<b>Internal credit transfer</b>	A service initiated by the payer consisting in enabling the transfer of funds between payment accounts held by the same service provider.
<b>Credit transfer in a foreign currency</b>	A service initiated by the payer to allow the transfer of funds from the payer's domestic payment account with the service provider to the payment account with the service provider's domestic payment account in a currency other than Polish zloty and Euro.
<b>Direct debit</b>	A service referred to in Article 3(2) of the Act of 19 August 2011 on payment services.
<b>SMS notification</b>	A service of transmitting messages concerning a payment account by means of text messages.
<b>Maintaining the account</b>	A service of maintaining a payment account for the consumer, enabling the safekeeping of consumer's funds and the execution of payment transactions, together with the service of opening or closing a consumer's payment account.

<b>Preparation of a statement of payment transactions</b>	A service initiated by the payer to prepare a statement of transactions made within the payment account in a given period, on paper or in electronic form, by the service provider of the payment account.
<b>Cross-border payment transaction using a debit card for non-cash payments</b>	A service of executing non-cash payment transactions using a debit card on the territory of another Member State, with the physical use of the card and without the physical use of the card.
<b>Cross-border payment transaction using a debit card for cash payments</b>	A service of withdrawing funds from a consumer's payment account on the territory of another Member State by means of a device enabling such a withdrawal to be made or at the service provider's premises.
<b>Issuing a payment card</b>	A service of issuing a payment card referred to in Article 2(15a) of the Act of 19 August 2011 on payment services.
<b>Providing a debit card</b>	A service enabling a payer to use a debit card referred to in Art. 2 (15a) of the Act of 19 August 2011 on payment services if the amount of each transaction made with the use of the card is debited to the payment account of the payer.
<b>Providing a credit card</b>	A service enabling a payer to use a credit card referred to in Article 2(15a) of the Act of 19 August 2011 on payment services if the amount of each transaction made with the card reduces the established credit limit of the payer.
<b>Issuing a certificate on the payment account held</b>	A service of issuing a certificate with information on the payment account or services provided to the consumer by the service provider of the payment account.
<b>Cash withdrawal</b>	A service of enabling cash withdrawal from a consumer's payment account via a device enabling such cash withdrawal or at the service provider's premises.
<b>US bank withdrawal</b>	The customer withdraws money from their PayPal wallet to a US domiciled bank account



<b>Cash deposit</b>	A service of enabling cash deposit into a consumer's payment account via a device enabling such cash deposit or at the service provider's premises.
<b>Telephone banking service</b>	A service of accessing a payment account by telephone through the use of the service provider's hotline, enabling, in particular, verification of the balance of the payment account or placing another type of instruction regarding the payment account.
<b>Electronic banking service</b>	A service of accessing a payment account via the Internet, enabling verification of the balance of the payment account, change of limits for non-cash payments and debit card transactions or placing another type of instruction regarding the payment account.
<b>Standing order</b>	A service initiated by the payer to cyclically transfer money in the determined amount from the payer's payment account to the payee's payment account.
